Dear Bishop and First Lady,

I started this letter last yesterday while at work, by hand, so I'm typing it this morning. The last letter that I sent to you with the letter to Obama is the last letter that I've written. I appreciated receiving the "Woman to Woman" letter from First Lady, but I have not felt like writing in some time. Despite my request for a transfer, it has not taken place yet. The County has a policy that if sexual harassment has taken place, then the offender is automatically fired. And, not wanting cause such a fate for my supervisor, I wrote an affidavit, stating that I was suffering emotional and medical problems on the job. The Deputy Director and Director knew my verbally expressed reasons for my request for transfer, but they seemed happy that the supervisor would not be fired. But then, someone high in Personnel wanted my medical records before the transfer: that's is what we are waiting for now.

Since 1966, with the exception of time spent in the Congo and D.C, I have worked in South Central, and have really loved doing it. The transfer will put me in another district, but work needs to be done there, too, so I'll adjust. On the other hand, I wish I could afford to rest, or even to retire. Born in 1942, I kind of feel that I need for more than a day off.

Remember when I told you about the 14 years for Tee? Well, whatever way they sentence, it comes out to 7 ½ years, of which he has served 6. He is also trying to appeal the original court action to the U.S. Federal Court. So, we'll see which occurs first.

Our President must own a vitamin regime, or own the factory — I have never seen such energy and determination of any President I have known in life. Since most of the activity is around the budget and the war, I can be of no help right now. I do hope that those who have such expertise, will support and give their plans. I have sent to Obama the letters I had written to Villaraigosa, regarding my experiences in the community, educational and social programs, but all this budget is foreign to me.

There is a Nigerian Church that I've been attending some Sundays; Some Africans that I know generally don't come, even to Church on time. My Evangelist friend called to tell me that Church started at 10am — I was the only one there, on time. Even the Evangelist, who was preaching that day, arrived after 11am. This is a centuries-long problem, but I plan to work with them, not only on punctuality, but also how to make a plan for their small congregation and what ministries they want

The Stimulus – The American Recovery and Reinvestment Act, Meeting held by Maxine Waters, Saturday, March 14, 2009 at

Southwest College, Los Angeles, California

Last Friday, I asked Mrs. Buzo if I could visit Maxine Waters EPC, to talk with Mr. Andre Charles, regarding the classes, especially the Construction Program for LAUSD, in regards to our GROW Participants. He was not there, in fact few classes are held there on Fridays, but I noticed a flyer, indicating that Congresswoman Maxine Waters would be speaking about Obama's Stimulus Program, the following day at SW College. I am providing a summary of my notes, but also, a copy of the Stimulus Report, provided at the Town Hall Meeting, in case I have omitted important information.

I did not catch some of the names of the panel presenters, but Bill Taylor, from LA County, Steve Bradford from Gardena, Michael Dolphin, a Mr. Irish, speaking on summer jobs, Jack Daniels, the head of SW College, a very knowledgeable woman from a Neighborhood Stabilization Program, to name a few. The Town Hall Meeting was held in The Little Theater and, roughly about 75-100 people were in attendance.

Congresswoman Waters spoke of the economy being down, causing a loss of 12.5 million jobs, 650,000 in the last two months, and the foreclosure meltdown and President Obama's Plan to stimulate the economy. There is a plan to create "Shovel-Ready" jobs, with 3.5 to 4 million jobs being created. Jack Daniels, from SW College, addressed the new construction at the college, itself, and the increased number of students at Southwest College.

Employment insurance benefits will be increased by \$25 a week, Food Stamps will be increased 13.6%, SSI increase is \$250 a month, Pell Grants to increase, Income Tax-more back, First-time Home buyers get \$8,000 off the purchase price in 2009, (First-time home owner described as not owning a home in three years and having no other property), Foreclosure Prevention Measures, Health Care coverage will be increased, job training programs, and a State measure to minimize teacher layoff. Under COBRA, 60% of Healthcare plan is paid, if you get laid off.

Bill Taylor, LA County, stated that \$150,000 was being added to CalWorks. \$1.6 million to Medicaid, \$80 a month increase in FS for family of four (\$720,000, overall), and 75,000 people on GR. There will be an increase to maintain medical benefits and IHSS care in homes. There will be a \$2 billion expenditure to put medical records on an Electronic system.

Unemployment insurance will go up \$25, as I said, starting 2/09 through 12/09. Inquiries can be made at 1 (800) 300-5616.

Irish and Michael Dolphin spoke about unemployment being at 232,000 in LA. \$35,000,000 has been funded to put people back to work, at the 18 WorkSource Centers and the 13 OneSource centers for youth. The number is 1 (800) for-a-job. Technical and education training will be given. There will be a one-time homeless benefit (?) and 10,000 jobs created in the private and County sector.

Jack Daniels spoke on the Summer Youth Program, with a plan for 2000 in classes to study skills, among them, Green solar, heating, A/C and healthcare classes. They plan to partner with employers and have a Coordinator of Youth for College program.

Besides the Housing Stabilization Program, mentioned earlier, the guidelines are to create new homeowners and to lengthen the time to pay for homes. People who have their property taxes, still assessed at the higher value were encouraged to have their homes reappraised for current market value. There is a \$4,900 new car credit on new vehicles, \$2,400 tax free deduction for unemployment insurance.

There were several questions about the Expo Park Metro proposal: one was about the train being designed above street level, for a cheaper amount, than those being designed for underground level in other parts of the city. There was also a question about Blacks not being hired for the jobs. Maxine Waters stated that we cannot protest until we have passed the drug test to get the job.

President Obama will be in Los Angeles on Wednesday, March 18, 2009.

All I can give are my thoughts and ideas, which I will be happy to do, and have done since my letters started in 1993. And, I believe that the sharing of our visions is the most important aspects for the solving of our problems.

Affixed to the television last week, as most of us were, at the amazement of the death of Michael Jackson, I could not turn my eyes away, but was struck by his philanthropy and popularity around the world. The vision of Michael, and his concern for the betterment of the world needs replicating among us all.

We must encourage parents to take part in their children's education by reviewing homework and attending their children's classrooms, hopefully, as often as possible, and consulting with the Principal, to assist the teachers, on a regular basis.

We have to disseminate increased knowledge about the Community—what it was like in more prosperous days, documentaries of the history, historic buildings, when the Dunbar Hotel was in its hay day, the musicians that played and serenaded the hot spots, the renowned leaders, artists, architects and educators that contributed to Los Angeles, etc.
